



2nd Memorial Miquel Galmez i Creus

(Barcelona, 1937- Barcelona, 31 August 31, 2015) was a photographer and historian of photography. Founder in 1972 of the Institute of Photographic Studies of Catalonia. Of which he was also its director and president

He had a special connection with Vilanova i la Geltrú; throughout his life, he participated in numerous activities related to the world of photography and culture in general.

BASES

PARTICIPANTS: Everyone who wants to participate is welcome.

THEMES: Free color, Free Black and White, Nature

WORKS: A maximum of four per theme and participant can be submitted.

FORMAT: The works must be submitted in JPG format, with the maximum size of the long side being 1920 px if the image is horizontal and 1080 px if it is vertical, a resolution of 300 dpi, keeping in mind that each file must have a maximum weight of 2 MB. The images must have a title.

Phrases like “Untitled“ will not be accepted, nor will photographic file names. If the size is larger, the photographs will be rejected automatically.

No type of watermark, signature, or identification of the author or artistic name is accepted, nor those that have frames or borders that in any way frame the image, nor the use of AI.

PARTICIPATION: The photographs must be submitted exclusively in digital format.

Registration fee: €16 per participant

Account number for payment: Payment will be made via Paypal, once the images have been uploaded.

JURY:It will be composed of three recognized individuals by the FCF.

VERDICT:It will be public and will take place on 01-15-27, at 4:30 PM at the Sant Joan Civic Center.

AWARDS CEREMONY: 5:00 PM. Sant Joan Civic Center VNG

EXHIBITION OF WINNING WORKS: To be announced

GENERAL CONSIDERATIONS:

- No more than one award will be given per author.
- The judging panel may not declare any award void.
- If, due to a serious offense committed by an author, their work must be disqualified, the possible award granted will go to the next contestant for all purposes.
- Participation in this contest implies full acceptance of these rules.
- Any unforeseen case will be resolved by the organizing entity.
- Participants will be fully responsible for any third-party rights in the submitted works. Also for claims that may be presented by intellectual property rights entities to which participants may be affiliated.
- The entity reserves the right to reproduce the awarded works and to select the works to be exhibited.
- This contest is point-scoring for obtaining the AFC-MFCF-EFCF, - ACEF-MCEF-ECEF distinctions.
